## Terms and Conditions - Asia in my Life photo competition:

1. Information on how to enter and prizes form part of these Terms and Conditions. **Entry into this competition is deemed acceptance of the Terms and Conditions.**
2. The Asia New Zealand Foundation reserves the right to store electronically any pictures sent in by readers and to use the images free of charge in any of its online and print publications. Photographers retain the copyright to their photographs.
3. The competition is open to **New Zealand residents and citizens only**. You must have a **New Zealand address** available to you to enter. Employees of the Asia New Zealand Foundation and their immediate families are ineligible to enter.
4. To enter the promotion, entrants must send an email entry to [competitions@asianz.org.nz](mailto:competitions@asianz.org.nz) with a photo taken that showcases “Asia in my life”, the photo's location and a short caption about the photo, as well as a New Zealand phone number. The subject line must have the category entered and the full name of the entrant (e.g. Food – Jane Smith ).
5. By entering the competition, the entrant acknowledges that the photo/s is the **property of the entrant**. They must not have been published elsewhere or have won a prize in any other photographic competition. It is the responsibility of each entrant to ensure that any images they submit have been taken with the permission of the subject and do not infringe the copyright of any third party or any laws. Entrants must warrant that the photograph they are submitting is their own work and that they own the copyright for it. It must be of reasonable quality, between **800KB to 5MB in size**.

8. Category winners will be selected by a panel of judges from the Asia New Zealand Foundation, and one external judge. The People’s Choice prize will be determined via a Facebook photo album where a like is equivalent to a vote.
9. The winners will be notified by email. Inability to contact the winner within fourteen days of selection will result in the prize being forfeited.
10. The winners consent to their name and photo being used for public relations purposes relating to this promotion.
11. Copyright of all images submitted for this competition remains with the respective entrants. Winning and shortlisted images may be used by the Asia New Zealand Foundation, the [asianz.org.nz](http://asianz.org.nz) website and the Asia New Zealand Foundation social media channels free of charge for publicity purposes in connection with this competition for a duration of no more than five years and will be credited if used.
