

## Terms and Conditions:

1. Information on how to enter and prizes form part of these Terms and Conditions. Entry into this competition is deemed acceptance of the Terms and Conditions.
2. The Promoters reserve the right to store electronically any stories sent in by readers.
3. The competition is open to New Zealand residents and citizens only. You must have a New Zealand address available to you to enter. Employees of the Asia New Zealand Foundation and their immediate families are ineligible to enter.
4. The competition entry period commences at 9.00am on 1 February 2022 and will finish at 5.00pm on 28 February 2022. Eligible entrants may enter more than one story.
5. To enter the promotion, entrants must send an email entry to [competitions@asianz.org.nz](mailto:competitions@asianz.org.nz) or post an entry to Short Story Competition, Asia New Zealand Foundation, PO Box 10 144, Wellington. Entries must reach the Foundation by the deadline of 5pm on 28 February 2022. The Foundation is unable to accept physical delivery of entries.
6. Entries must include the entrant's name, age, and a parent or teacher's name and contact details (including a phone number) and provide the name of school or whether home-schooled.
7. The Promoters are not responsible for late entries sent by email or post or lost, misdirected or incomplete entries.
8. Stories must not have been published elsewhere.
9. Entrants must be current students studying at Year Levels 5 to 13 at the time of entry. Eligible entrants may enter more than one story.

14. The Foundation will publish the name and photograph of the winners of each category once parental consent has been obtained.
15. Winning and shortlisted stories may be published by the Asia New Zealand Foundation on the [asianz.org.nz](http://asianz.org.nz) website and promoted on the Asia New Zealand Foundation social media channels free of charge for publicity purposes in connection with this competition.
